## **INSTRUCTIONS & GENERAL CONDITIONS**

- 1. All candidates will be selected on merit, observing the quota as per Federal Government Policy.
- Age relaxation allowed as per government policies is already given against all posts. No further age relaxation is allowed in the prescribed age limit except the candidates belonging to Scheduled Cast, Buddhist, FATA, Gilgit Baltistan & AJK for further 03 years.
- Government Servants who have completed 2 years continuous service on the closing date of applications are advised to apply through proper channel. Candidates have to provide departmental No Objection Certificate at the time of interview in original.
- 4. Only shortlisted candidates will be called for Test / Interview.
- 5. No TA / DA will be allowed to the candidates for test / interview.
- 6. Concealment or misrepresentation of facts at any stage will lead to disqualification of the candidate even after appointment.
- Only those candidates who fulfill the requisite qualifications / criteria are eligible to apply. Candidates to whom final mark sheets have not been issued shall not be considered. The candidates awaiting results are not eligible to apply.
- 8. No applications in person / through courier will be accepted in HESCO.
- 9. Last date for submission of online applications is 22.01.2025.
- 10. The candidates shall be called for interview / further process subject to detailed scrutiny of documents and after checking eligibility under the rules. Mere passing of written test does not make the candidate eligible for further recruitment process.
- 11. Eligibility of the candidates shall be determined on the basis of academic qualifications, written test and interview marks.
- 12. Conversion certificate issued by the university / institute (conversion from CGPA to percentage of the total marks) is mandatory at the time of interview
- 13. Dismissed / screened out employees of any organization or having criminal record are not eligible for employment.

Applications incomplete in any respect and received after the due date will not be entertained.
